Amateur Minor Athletic Waiver and Release of Liability (Required)

In consideration of being allowed to participate in any way in Pa'ia Youth & Cultural Center athletics/sports programs, and related events and activities, the undersigned:

1. Agree that the parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions, or negligence but the action, inaction and negligence of others, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent total disability or death.
4. Release, waive, discharge and covenant not to sue Pa'ia Youth & Cultural Center, its affiliated clubs, their respective administrators, directors, agents and other employees of the organization, other members/participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releases," from any and all claims, demands, losses or damages on account of injury, including death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.

Internet Acceptable Use Policy (Optional)

PYCC reserves the right to deny access privileges to any member who violates PYCC requirements. Access is provided to all PYCC members with the following expectations:

1. *Parents*, and not PYCC, are responsible to supervise and guide the use of the Internet by their children.
2. PYCC has no control over the material on the Internet other than what PYCC has directly posted via its own home page. PYCC cannot protect its members from offensive material.
3. Members may not give out the phone number or location of PYCC to anyone they meet online, whether they believe the person they are chatting with is someone they think they know or not. Members are encouraged to visit areas that are appropriate for their age. Members are encouraged not to give out information that would in any way allow anyone they meet online to contact them outside of the internet. Members are to refrain from any Internet use that includes sexual references, pornographic language or images.
4. It is not appropriate to use Internet privileges to interfere with or disrupt other users, services, activities, programs or equipment. Members will not use the Internet for any illegal activity, or place any text, data, graphics, images, messages, communication, files or other material related to any illegal activity on the Internet.

3. **Don't Make Assumptions**; Find the courage to ask questions and to express what you really want. Communicate clearly to avoid misunderstandings, sadness and drama.
4. **Always Do Your Best**; Your best is going to change depending on if you're sick or healthy. Simply always do your best and you'll love yourself. Respect that others are doing their best for who they are in the moment.
